| <p><b>Objective:</b></p> <p>The objective of the Fund is to provide long term capital appreciation.</p> <p><b>Policy:</b></p> <p>The Fund will seek to achieve its investment objective through investment in a diversified portfolio of collective investment schemes, transferable securities (including investment trusts), warrants, deposits and money market instruments. In doing so the Fund will invest in and gain exposure from time to time to equities, bonds, hedge funds, private equity, debt instruments, physical assets and hard and soft commodities, which may include art, wine, gold, oil and other commodities.</p> <p>The Fund will only make investments into collective investment schemes where their net asset value calculations are scheduled on at least a monthly basis and where, at the time of investment by the Fund, the Investment Adviser is satisfied that the assets are fully liquid.</p> <p>Subject to the requirements of the Regulations, there will be no restrictions on the underlying content of the investments held, in terms of investment type, geographical or economic sector, other than those imposed by the Regulations, meaning that the Investment Adviser has the absolute discretion to weight the portfolio towards any investment type or sector at any time.</p> <p>The use of derivatives and/or hedging transactions are permitted in connection with the efficient portfolio management of the Fund, and borrowing will be permitted under the terms of the Regulations.</p> | <p><b>Benchmark:</b></p> <p>The appropriate comparator benchmark against which the performance of the Fund can be measured is the Investment Association's IA Flexible Investment sector.</p> <p><b>Other information:</b></p> <ul style="list-style-type: none"><li>Investment in the Fund should be regarded as long-term, which is at least five years.</li><li>There can be no guarantee that the objective of the Fund will be achieved.</li><li>On encashment, particularly in the short-term, you may receive less than the original amount invested.</li><li>In relation to share classes where there is an Entry Charge (see overleaf), the charge is deducted from your investment at the outset. Therefore, an equivalent rise in the value of shares is required before the original investment can be recovered. Various other charges accrue daily.</li><li>The Authorised Corporate Director (ACD) carries out investors' requests, to buy, sell or switch, at 12:00 hours (UK time) on each business day (which excludes public holidays in England and Wales). If the ACD receives a request after 12:00 hours (UK time), the ACD will deal with it on the next business day.</li><li>As you hold income shares, income that is available from the Fund is paid out to you twice a year.</li></ul> |

It can also invest to a greater extent in areas such as property and unregulated schemes and have the option to borrow on a permanent basis. 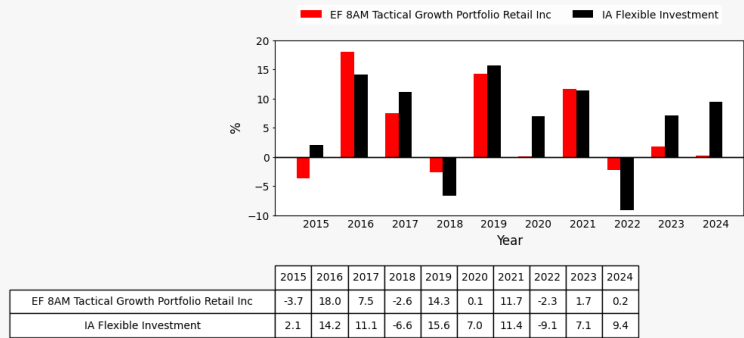
