Investment Objective and Investment Policy

Objective:

To achieve an income with potential for some capital growth by investing in markets in both the UK and overseas.

Policy:

The Fund will typically invest a minimum of 80% of its net asset value in collective investment schemes, exchange traded funds and unregulated collective investment schemes.

The Fund may also invest in investment trusts (and similar instruments), other transferable securities, money-market instruments, fixed income instruments, deposits and foreign exchange contracts.

It is expected that exposure to equity markets will typically range from a minimum of 20% to a maximum of 60% of the total Fund, with the aim of achieving the Fund's objective. However, investments will not be confined by industrial, economic or geographical sector.

The Fund may also hold, on a temporary basis, all or part of its assets in cash or other ancillary liquid assets.

The Fund may utilise derivatives for the purposes of efficient portfolio management (typically hedging, including investing in hedged share classes, which attempts to mitigate against falls in the value of the Fund's assets and the effects of changes in currency exchange rates against the Fund's base currency, which is Pounds Sterling).

The Authorised Corporate Director (ACD) does not intend to have an interest in any immovable property or tangible movable property.

Benchmark:

The appropriate comparator benchmark against which the performance of the Fund can be measured is the Investment Association's IA Mixed Investment 20-60% Shares sector.

Other information:

- The Fund's base currency is Pounds Sterling.
- We carry out investors' requests, to buy, sell or switch, at midday on each business day (which excludes public holidays in England and Wales). If we receive a request after midday, we deal with it on the next business day.
- Investment in the Fund should be regarded as long-term, which is at least 5 years.
- There can be no guarantee that the objective of the Fund will be achieved.
- On encashment, particularly in the short-term, you may receive less than the original amount invested.
- As you hold income shares, income from investments in the Fund will be paid out to you twice a year. The income paid may vary for each distribution period.

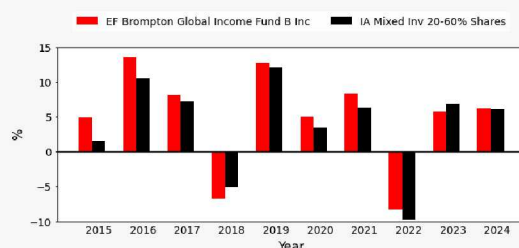
The ongoing charges figure is based on expenses for the period ending 31 January 2025 and may vary from year to year.
