WAY Absolute Return Portfolio Fund

We wrote to you on 2 April 2019, to inform you that we were suspending dealing in the Fund and then again on 31 May 2019, to confirm that we had received the FCA's authorisation to proceed with the termination of the Fund.

We are now in a position to make the first distribution of the Fund's available capital to you, which is equivalent to:

Cash payment

If a cash payment has been made by us and we have your bank details on file, the payment will be made to your bank account within the next 2 business days. If we don't have your bank details, a cheque will be attached in settlement.

As the remaining assets are realised, we will make further distributions of the Fund's capital to you. At this point we are unable to confirm when these distributions of capital will be made, or the value of those distributions.
